Part A: Pupil premium strategy plan

Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy is also integral to wider school plans for education recovery, notably in its targeted support through the National Tutoring Programme for pupils whose education has been worst affected, including non-disadvantaged pupils.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set;
- act early to intervene at the point need is identified;
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve.

What are your ultimate objectives for your disadvantaged pupils?

To ensure that all pupils eligible for the Pupil Premium Grant make academic and social progress across the school that is at least in line with their peers. We recognise that excellent teaching is a key component to enable schools to improve outcomes for disadvantaged pupils, we therefore offer education which is challenging, enjoyable and knowledge rich. We will have succeeded if our pupils demonstrate readiness for learning, readiness for life and are given the chance to achieve the best results possible.

How does your current pupil premium strategy plan work towards achieving those objectives?

Overcoming barriers to learning is at the heart of our pupil premium strategy. We use evidence-informed research to make decisions about the best approaches for all our pupils. By identifying key barriers to success for children and seeking to put in place pragmatic and effective solutions

to overcome them, our pupil premium strategy works to achieve our ultimate objectives for our disadvantaged pupils as outlined above.

What are the key principles of your strategy plan?

- Recognising that all children are unique individuals and that to best support them we
 must look at individual strengths, difficulties and characteristics and be able to offer
 support for emotional and mental wellbeing where needed.
- Ensuring all pupils have access to high quality teaching and learning.
- Providing targeted academic support for pupils who are not making expected progress.
- Addressing non-academic barriers to learning such as attendance, behaviour, mental health and adverse childhood experiences/trauma.
- Working with parents to ensure that pupils have the necessary resources for learning and are given opportunities to participate in extra-curricular activities, and educational visits.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Assessments, observations, and discussions with pupils suggest that some disadvantaged pupils have greater difficulties with phonics than their peers. This negatively impacts their development as readers. Some have poorer vocabulary and lack general knowledge and this can impede their overall academic progress.
2	There is a coincidence of SEND and disadvantaged pupils across the school 28% of our whole school SEND (9 pupils/32 on the SEN Record). This means that individualised SEND approaches are needed to accelerate progress for many of these children.
3	Our assessments and observations indicate that the wellbeing of many of our disadvantaged pupils have been impacted by partial school closures to a greater extent than for other pupils. These findings are supported by national studies.
4	Our assessments, observations and discussions with pupils and families have identified social and emotional issues for many pupils, notably due to self-esteem, friendships and a lack of enrichment opportunities during school closure. These challenges particularly affect disadvantaged pupils, including their attainment.
	Teacher referrals for support from our Pastoral Support Lead have markedly increased post pandemic. 11 pupils (4 of whom are disadvantaged) currently require frequent and regular timetabled additional support with social and emotional needs.
	Some children, due to financial circumstances, are not able to access the opportunities provided for other pupils.

	Numbers of children receiving the grant are relatively low, and their home contexts vary widely. There is a need for an individual approach for each child not just academically but also for their social and emotional wellbeing.
5	Our attendance data over the last 2 years indicates that attendance among disadvantaged pupils has been between lower than for non-disadvantaged pupils.
	Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.

Intended outcomes

Provide support for children with their emotional wellbeing to allow them to enjoy school life and be successful and aspirational. The average impact of the Parental engagement approaches is about an additional four months' progress over the course of a year. There are also higher impacts for pupils with low prior attainment.	
The evidence about how to improve attainment by increasing parental engagement is mixed and much less conclusive. There are examples where combining parental engagement strategies with other interventions, such as extended early year's provision, has not been associated with any additional educational benefit. This suggests that developing effective parental engagement to improve their children's attainment is challenging and needs careful monitoring and evaluation.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

Key Outcomes

KS2

Attainment of EXS+ and progress, was well above national averages with further improvements on 2019 in most measures.

- Hopton pupils made positive gains against the national averages in all measures except Reading at higher standard.
- Attainment of EXS+ was above the national averages in all measures. Reading (+2%), writing (+7%), maths (+15%) and RWM combined (+10%).
- Progress was well above national in Reading (+1.2), writing (+2.2) and maths (+2.1).
- Groups
 - Disadvantaged (3 pupils). EXS+ Reading 33% (Nat 63), Writing 33% (Nat 56%), maths 67% (Nat 57%) and RWM combined 33% (Nat 43%). This was a small cohort.
 - Non disadvantaged above national in all subjects.
 - EAL (2 pupils). 100% EXS+ above national in all subjects.
 - SEN K (5 pupils). EXS+ reading 40% (Nat 43%), writing 60% (Nat 30%), maths 60% (Nat 40%) and RWM comb 40% (Nat 21%). Attainment of SEN was in line with or above the national average for this group.

KS1

Hopton pupils made very positive gains to well above the 2022 national averages in all subjects and the combined measure.

- Attainment in Reading improved by +33% since 2019 against the national average to 90%, +22% above the national of 67%.
- Attainment in writing improved by +30% against the national average to 79%, +21% above the national of 58%.
- Attainment in maths improved by +36% against the national average to 100%,
 +32% above the national average of 68%.
- Attainment of pupils achieving the higher standard was in line with national in Reading and writing and well above in maths.
- Attainment of the 1 disadvantaged pupil was 100% in all subjects at EXS+.
- Attainment of the 2 SEN pupils was 50% in Reading, 0% in writing and 100% in maths.

Phonics

• Attainment in the Year 1 phonics improved strongly by +17% compared to the national average since 2019 to 89%, +13% above the national average of 76%.

EYFS

- Attainment of a GLD was 67%, +2% above the national of 65%.
- There was considerable parity in children's attainment of the ELGs across the 17 strands.
- Attainment was slightly lower in self-regulation, fine motor, writing, word reading and number.

Attendance - From FFT attendance tracker

Attendance was very strong in 2021/22 and is currently in line with the FFT national in 2022/23 to date.

- 2018/19 96.2% (Nat 96.0%) slightly above.
- 2020/21 94.6% (Nat 96.4%) below.
- 2021/22 95.3% (FFT Nat 92.8%) +2.5% well above national. FSM6 92.2% (FFT Nat 90.5%) +1.7% well above national.
- Attendance was above the FFT national average for all pupils (+2.5%), FSM6 pupils (+1.7%) and SEN K pupils (+4.3%).
- 2022/23 to date: 95.13% (FFT YTD Nat 95.2%) in line with FFT national.
 FSM6 97.5% (FFT Nat 93.2%) +4.3% well above.

We used pupil premium funding to continue to provide wellbeing support for all pupils and targeted interventions where required. We are building on that approach with the activities detailed in the plan above for 2022-23.
